

The ASE index Quarterly review

Mr. Mazen Wathaifi the Chief Executive Officer of the Amman Stock Exchange (ASE) said that the ASE has conducted the periodic quarterly review of the ASE indices constituents in purpose of ensuring that these indices reflect the market performance and the trading activity of the listed companies. By this rebalancing, the activity of listed companies in regard to trading during the last quarter has been reviewed. After that, the ASE has conducted its screening process for all listed companies based on the criteria used by the ASE represented by full market capitalization of the companies and the number of trading days during last quarter.

Mr. Wathaifi added that an amendment has been made to the General Index sample to include all companies that meet the requirements for selecting the sample without limiting the number of companies in the sample. As a result of this review, the number of companies that meet the requirements for selecting the general index ASEGI sample were 74 companies

Regarding the General index ASEGI, Mr. Wathaifi clarified that the index sample includes the most active companies at the ASE and the highest in terms of market capitalization. The full market capitalization of the index constituents represents 93.4% of the total market capitalization of the companies listed on the ASE. The free float market capitalization of the index constitutes represents 95.7% of the total free float market capitalization of the listed companies on the ASE.

As for the ASE20 and ASETR indices the full market capitalization of the index constituents represents 85.3% of the total market capitalization of the companies listed on the ASE, while the free float market capitalization of these companies represents 87.4% of the total free float market capitalization of the ASE listed companies.

As part of the process, the ASE calculated the free float for all listed companies on the ASE based on the data received from the Securities Depository Center. This review also includes the reduction of the weights for some companies to maintain the 10% cap that applied to index constituents.
